Publicity Report

Commissioner Jeanine Purcella stated informed members that every other Thursday Western CT students will test for zebra mussels. In addition, First Light will have a presentation on water flow next Thursday, 8/11/11, 7:00pm at Riverside Firehouse. All are encouraged to attend.

Commissioners Ray Hoesten and Marven Moss continue to test and review the water quality of the lake.

Commissioner Ray Hoesten briefly discussed the DEP seminar he attended last Saturday. Approximately 17-20 people attended the seminar. The DEP representative provided an overview of the overview of invasive plants and zebra mussels. She cautioned residents about the importance of removing the weeds that are become entangled on the boats

Mr. Hoesten thanked Marven Moss for all his hard of work. He has worked diligently on ensuring that our work and the needs of the lake are publicized on the radio and in the newspaper.

Other Items

Bob Barnes mentioned the he received a letter regarding First Light funding. It will no longer provide grants that range up to \$60,500.00. Moving forward, it can only provide grants up to \$5,000.00

2. An individual informed us that they pulled a large amount of copper wire from the water.

Water Quality

Commissioner Ray Hoesten had a meeting with Neil Lustin regarding the lack of reports from the water quality testing. Bob Barnes recommended that Ray stop testing since the State has not provided the Authority with any results.

Commissioner Jeanine Purcella stated a letter from the Authority to all of the towns should be drafted to explain the testing situation. Bob Barnes requested that the letter is addressed to Bill Davis of First Light, and all of the towns will be cc'd. The letter will clearly explain the State's inability to provide the test results from the water testing

Boat, Motors Maintenance:

Robert Bowolick provided an overview of the latest Boat maintenance developments:

July 17th: Informed Unit 1 prop and lower unit damaged while in the vicinity of the Shephaug Dam. Visual check showed the skeg was broken off and the prop edges

distressed but not bent. A performance test run showed the boat to be slower to get on plane with some degradation in handling characteristics. A refurbished prop is available. Requested Lakeside Marine prepare an estimate for the cost of repair or replacement of the skeg. Recommend repairs of the skeg and the propeller be made after the 2011 boating season and the damaged propeller to be sent out to be refurbished.

July 22: Obtained life jackets from Sea Tow for both units. Each unit has two toddler and two child life jackets for distribution to boaters stopped for inadequate life jackets. These jackets do not have to be returned to the LZA

July 25^t: Participated in water quality test with George Nokline and Bernie Lintzner

July 31: Informed a large tress was a hazard to navigation and was towed to Jackson Cove. A dove line was lost in the process. Notified remote controlled spot lights on both boats are inoperative. Unit 1 light will glow but not swivel and Unit 2 does not operate at all. Researchers the internet for manufacturer's recommended installation and maintenance procedures.
